Market Overview -

Nifty opened in negative and immediately recouped. Dow Jones closed by more than 400 points which created a negative environment for the Asian market also. Hang sang and Kospi showed weakness and SGX Nifty was 120 points down. During the day, the Banking, Auto, and Paint sectors helped Nifty to close in red after four consecutive red closing days. The metal sector bleeds due to the global supply increase in industrial metal space. Coal India and Tata Steel were the top loser stock during the day. Finally, Nifty50 closed in red and Nifty Bank closed in the green zone keeping traders in cautious mind for tomorrow's trade. The Indian markets are still volatile due to geopolitical tension and global inflation.

Our take- we expect Nifty50 to trade between 16050-16450 levels for tomorrow's trading session and suggest a buy-on dip and sell on rise strategy with the stop loss of 100 points.

Banknifty may find support near 34000 and resistance around 34900 levels.
