### Market Overview -

#### Bulls regain last two days loss

The Indian stock market witnessed impressive buying from their lower levels. SGX Nifty indicated flat to positive opening after taking mix cues from Asian and Global markets. Nikkei closed near to flat and Hang Seng witnessed buying strength from lower levels. Coming to USA market, Dow Jones closed near to flat and Nasdaq dragged 1.2% down. All eyes on inflation data which may release on Thursday. Domestically, good rebound seen in the major indices Banking and Auto Sector has outperformed Nifty50. Whereas, Pharmaceutical and Paints were under performer. Indian agencies has released CPI AND WPI data on Wednesday evening which disappointed the street and we may see volatile impact on Thursday trading session.

Our Take- Nifty50 support may place around 16900 and resistance around 17300 levels.

Nifty Bank support may place around 38750 and resistance around 39500 levels.
