Market Overview -

Choppy movement throughout the day.

The Indian stock market witnessed choppy movement throughout the day. Nifty50 and Nifty Bank were trading in a narrow range during the day, but at the time of closing Nifty Bank performed quite well and closed near the day's high level which indicates the bulls are still present on every lower levels. Major Asian and European markets were also opened on flat note. Technically, bullish candlesticks pattern with long shadow can be seen for Nifty50 daily chart. Most of the short and long term technical indicators are suggesting that we are heading towards all time high levels and we may break that too before end of the year . We also suggest to investors make long positions on correction/ dip. Intraday traders may do short sell and take advantage of higher levels but strict stop loss is mandatory before taking any Intraday positions.

Our Take- Nifty50 may take support around 18250 levels and resistance around 18520 levels.

Nifty Bank may find support near 42000 levels and resistance around 42800 levels
