Big relaxation to Adani Group

Global Indices

The Indian stock market witnessed wild swings throughout the day, Adani group shares rose after supreme court of India announced relaxation for Adani's and found no price manipulation in the group companies. Adani Enterprise and Ports were closed 19% and 7% respectively. Recently, RBI stopped withdrawal of Rs 2000 notes but remained legal tender till September 2023, people rush to buy gold and currencies. There is a rumours that some people charged 10-15% premium in the exchange of Rs 2000 points. On the other hand, NestleInd, Heromotocop and EicherMot were remained under pressure. We expect volatality may likely to continue in coming days.

Our Take- Nifty50 support may place around 18250 and resistance around 18400 levels.
