Market Overview -Upward Trend Continues

The upward trend persisted throughout the week as major indices continued to show positive momentum. The Nifty50 closed the day with a gain of 45 points, while the Bank Nifty surged over 150 points at the end of the day The Dow Jones also experienced a significant surge of over 700 points, indicating a more active presence of bullish activity in the US market. The top gainer for the day were Hindalco and Apollo Hospital at around 2% increase. On the other hand the top losers were Adanient and BPCL both of them closed around 2% down.

Our analysis suggests that Nifty 50 may find support around the 18750 level, while resistance levels are anticipated to be in the range of 18600-18650.

Nifty Bank, support is expected around 44500, with resistance levels projected to be around 44000.
