The Indian stock market closed in green in today's trading session. Nifty50 closed at 19,765.00 which is up by 0.52% Points whereas other manor indices such as Nifty Bank, Nifty IT & Nifty FMCG closed 1.06 %, 0.42%,-0.41% respectively

The top gainers of the day were COALIND gained 6.92%, L&T gained 4.25% & INDUSINDBKgained 2.08%, Whereas top losers were TATACONSUM which lost -2.27%, ONGC which lost -0.98% & BRITANNIA Lost -0.90% Points.
