

Market Overview -

Indian markets closed in Green

The Indian stock market closed in green in today's trading session. Nifty50 closed at 20,192.30 which is up by 0.44% Points whereas other manor indices such as Nifty Bank, Nifty IT & Nifty FMCG closed 0.50 %, 0.94%,-0.48% respectively,

The top gainers of the day were BAJAJ-AOTO gained 6.29% points, HEROMOTOCO gained 2.25% Points & M&M gained 2.17% points, Whereas top losers were BPCL which lost -1.60% points, HINDUNILVBR which lost -1.27% Points & ASIANPAINT Lost -1.24% Points,

The major announcement & news were the Samhi Hotels IPO: Muted response seen on 2nd day of bidding, subscribed 11%, Maruti Suzuki partners with Indian Bank to provide financing solutions to dealers, Crude oil prices at ten-month high.
