## Indian markets closed in Red

The Indian stock market closed in green/red in today's trading session. Nifty50 closed at 19751.00 which is down by -43.00 Points whereas other manor indices such as Nifty Bank, Nifty IT & Nifty FMCG closed -0.70 %,-0.61 %, 0.30 % respectively

The top gainers of the day were TATAMOTORS gained 4.73% points, HCLTECH gained 2.72% Points & INDUSINDBK gained 2.44% points, whereas top losers were AXISBANK which lost -2.40% points, ADANIENT which lost -2.29% Points & INFY Lost -2.33% Points

The major announcement & news were the Phoenix Mills surges 6% to hit a new high on positive outlook, Exports dip 2.6% to \$34.47 billion in Sep; trade deficit narrows to \$19.37 billion, SEBI tweaks guidelines on anti-money laundering; partners with 10% stake to come under beneficial owners.
