The top gainers of the day were BAJAJ-AUTO gained 2.87% points, HINDALCO gained 1.57% Points & SUNPHARMA gained 1.46% points, Whereas top losers were POWERGRID which lost 2.11% points, ITC which lost -1.36% Points & TECHM Lost -1.23% Points

The major announcement & news were the Sugar output down 11% at 74 lakh ton during October 1-December 15 of 2023-24 market year, Saurabh Mukherjee's little champs fund stands alone with 12% dip in PMS returns, Mercedes Benz to carry out level 3 autonomous driving tests on designated highways in Beijing.
