The Indian stock market closed in green in today's trading session. Nifty50 closed at 21349.40 which is up by 94.40 Points whereas other major indices such as Nifty Bank, Nifty IT & Nifty FMCG closed -0.73%, 2.27%, 0.54% respectively






The top gainers of the day were WIPRO gained 6.43% points, HCLTECH gained 2.61% Points & BAJAJ-AUTO gained 2.37% points, Whereas top losers were GRASIM which lost -1.83% points, HDFCBANK which lost -1.07% Points & BAJFINANCE Lost -1.05% Points
