

The Indian stock market closed in green in today's trading session. Nifty50 closed at 21,654.80 which is up by 213.50 Points whereas other manor indices such as Nifty Bank, Nifty IT & Nifty FMCG closed 1.17 %, 0.70 %, 056 % respectively

The top gainers of the day were ULTRACEMCO gained 4.50% points, HINDALCO gained 4.25% Points & BAJAJ-AUTO gained 3.86% points, whereas top losers were ONGC which lost -0.94% points, NTPC which lost -0.90% Points & ADANIENT Lost -0.68% Points
